Home care workers face a variety of safety challenges, including unsafe neighborhoods; use of mass transit; encountering other individuals, weapons and animals in the household; illicit drug use in the home and/or neighborhood; and more. This interactive session will expand upon and highlight agency and employee responsibilities in workplace safety, including the development of a workplace violence prevention plan, as well as provide education for staff on safety tips, and measures; improved situational awareness; index of suspicion, and de-escalation strategies.
