

A letter from the President

New York's legislative landscape this year has been a veritable boxing arena, where diverse political interests and pressing social issues converged, forcing us to duck, weave, and stay on our toes. Setting the tone, Governor Hochul invoked Teddy Roosevelt's "Citizenship in a Republic" speech in her opening State of the State Address, likening herself to the "woman in the arena". This analogy presaged a tough budget fight, as the negotiations quickly turned into a bout of endurance and strategy.



The looming \$4.3 billion deficit was a heavyweight opponent, tempering our expectations. HCP stepped into the ring with a solid request for a 10% Medicaid rate increase for home care providers, hoping to counteract rising operational and wage costs. The governor's opening salvo—a staggering \$1.2 billion in Medicaid cuts, including an unallocated \$200 million slash in Medicaid long-term care funding—was as disappointing as it was disconnected from the wants and needs of New Yorkers. She followed with another heavy hit in her 30-day amendments, proposing to replace the Fiscal Intermediary (FI) procurement process with an authorization process and altering eligibility and participation criteria in the Consumer Directed Personal Assistance Program (CDPAP).

HCP's advocacy with legislative champions in both houses was evident when both the Senate and Assembly rejected the proposed Medicaid cuts, signaling a fierce budget battle centered around Medicaid spending. Despite widespread support in the legislature, the final round was decided by legislative leadership. The governor, along with Assembly Speaker Carl Heastie and Senate Majority Leader Andrea Stewart-Cousins, announced agreement on a state budget that included a Request for Offers (RFO) targeting Fiscal Intermediaries, threatening to fundamentally reshape the home care landscape should it be implemented. Our members and home care advocates from around the state rallied in unprecedented numbers to ensure a robust marketplace of providers. That fight continues in the courts and in the court of public opinion.

The unexpected became a persistent sparring partner. Yet, in the face of these relentless challenges, our members' dedication and resilience shone through. Together, we stayed in the fight, advocating for the resources and policies needed to sustain and grow our sector, and ensuring that quality care remained a cornerstone of our commitment to New Yorkers.

We had some significant victories this year! Along with battling back massive Medicaid cuts, we defeated a cut to Worker Wage Parity for Personal Assistants. We prevented hospitals from performing home care services without going through the proper process. We killed two legislative bills in committee. Our policy recommendations were robustly incorporated into the Master Plan for Aging. The bell has not yet rung, and HCP is ready for the next round.

I favor Roosevelt's lesser-known remarks made at the 1903 New York State Fair in Syracuse. "The welfare of each of us is dependent fundamentally upon the welfare of all of us." Our members never stop giving their all to provide care that New Yorkers need and want, and we will never stop fighting for our industry.

NYS POLITICAL LANDSCAPE

New York's legislative landscape leading up to the 2024 budget session was a dynamic and intricate arena where diverse political interests and pressing social issues converged. With a predicted \$4.3 billion deficit looming, the budget discussions were particularly charged, and advocates were warned that it was going to be a very challenging budget. Legislators from both sides of the aisle scrutinized Governor Kathy Hochul's proposals, which aimed to balance the budget by curbing spending growth in key areas such as education. Progressive factions pushed for higher taxes on the state's wealthiest residents, while the governor maintained her stance against new tax increases, arguing that the current tax burden was already substantial for New Yorkers. This fiscal tension set the stage for a complex and often opaque negotiation process where economic prudence had to be weighed against social equity and investment in essential services.

Amidst this fiscal backdrop, other significant issues shaped the legislative environment. The state grappled with a migrant crisis, widespread fear of crime including hate crimes, and the challenges of an aging population, all of which demanded urgent and effective policy responses. The Medicaid-funded home care sector, in particular, faced uncertainty with proposals that would significantly alter funding and service delivery models. As legislators engaged in budget hearings and negotiations, HCP mobilized to ensure that the voices of essential home care service providers were heard and considered in the final budget. This period of legislative activity was crucial for setting the state's priorities and ensuring that the budget reflected a balanced approach to fiscal responsibility and social welfare.

TALKING ABOUT MLTC REPEAL

The idea of repealing NY's Medicaid Managed Long Term Care (MLTC) program has been around since the program's inception, with proposed alternatives in play including returning to a fee-for-service model and replacing the system with a statewide single-payor system. HCP's Public Policy Team noted increased interest in MLTC repeal with chatter about the Home Care Savings & Reinvestment Act, S7800 (Rivera) /A8470 (Paulin), introduced in late 2023.

The bill was championed by 1199/SEIU and opposed by MLTC plans, leaving our members wedged between two very powerful groups: labor and insurance. Agencies reported being approached by advocates of both positions, some aggressively requesting that the agency sign a letter to support or oppose the bill.

HCP's Public Policy Committee met to discuss the bill, and determined that HCP would keep its focus on the bigger picture: home care's need for adequate funding, regardless of payment system. The bottom line: any reforms to managed care must address sufficiency, sustainability, and transparency if they are to succeed.

Our members needed language to respond to requests and tactics to employ when pressured to take a position on the legislation. In response, we created "Home Care Talking Points: Speak Confidently and Consistently About Home Care Issues in the State Budget." HCP's Public Policy Team provided guidance emphasizing the importance of pivoting the conversation to highlight broader funding needs. We delivered our guidance through our weekly *HCP Insider* and in-person at our Annual HCP Forum.

Regardless of individual members' position on the legislation, HCP offered support for crafting responses that align with the Association's broader advocacy goals. Through our online Advocacy Action Center, HCP provided tools and resources to help agencies engage with elected officials and advocate for the essential funding needed to sustain high-quality home care services. This message carried forward to our in-person Advocacy Day and was incorporated into our recommendations for the MPA.

THE MASTER PLAN FOR AGING

In November 2022, an Executive Order launched the Governor's Master Plan for Aging (MPA), establishing a framework to support healthy lives for older adults and individuals across all sectors. Over 350 participants in 32 workgroups contributed thousands of volunteer hours, with many, including HCP, taking active roles and chairing key home-care-centered groups.

HCP's Public Policy team played a crucial role in the Long Term Supports and Services, Home and Community-Based Services, and Formal Caregiving subcommittees. Our impact is evident in the MPA's formal recommendations, which were iterated across various workgroups. HCP's policy priorities are reflected in MPA recommendations on equity, access to care, payor structure, and worker retention.

Key issues identified across many workgroups were investment in strategic initiatives and inadequate reimbursement for providers, limiting workforce recruitment and retention. Several workgroups supported the Fair Pay Accountability Act (S6963 Rivera / A7335 Paulin), a bill HCP helped develop, aiming to ensure fair compensation for home care workers, fair reimbursement to provider agencies, and improved transparency in Medicaid spending.

Recommendations spearheaded by HCP and iterated in other workgroups supported S328 (Rivera) / A6346 (Paulin). Introduced in 2023, this bill would expand access to services by removing certain restrictions on eligibility regarding activities of daily living.

Innovations in caregiver training were another focus, with many MPA workgroups suggesting career advancement and mentorship programs to improve job satisfaction and retention. These initiatives, including HCP's Legacy of Care Mentorship Program offered through our affiliate, the NYS Home Care Providers Foundation, aim to address the workforce challenges in New York's home care system. Additional recommendations included:

- Advocate with federal legislators for improved immigration policies based on proposals from the Bipartisan Policy Center (BPC)
- Conduct a study to better understand the impact wage increases have on safety net benefits the long term care workforce relies upon
- Provide services and supports to disconnected young adults to assist them in entering the LTC training programs
- State investment in a long term care caregiver recruitment campaign
- Expand the use of hybrid training programs including financial incentives for agencies

While the MPA itself appears to be stalled, HCP will continue to fight to advance many of the policy recommendations put forth in the process. Our goal is the success of our members, on whose behalf we will advocate for enhanced financial sustainability, reduced regulatory burdens, and increased data transparency. As we look ahead, HCP is dedicated to turning these recommendations into actionable change, striving to create a more equitable and sustainable home care system.



EMERGENCY DAY OF ACTION IN ALBANY

On April 15, over 300 advocates for home care, including associations, providers, lobbyists, lawyers, vendors, banks, insurers, and caregivers, gathered in Albany to rally against a proposal to consolidate Fiscal Intermediary (FI) services under one entity.

Urged by a heartfelt personal plea from HCP Board Member and Long Island Chapter President Julian Hagmann, advocates from across New York and beyond quickly mobilized, demonstrating their commitment to preserving the integrity of a strong FI marketplace, safeguarding consumer interests, and supporting home careln a concerted effort that spanned four hours, advocates conducted rolling walk-ins to every legislative office, engaging lawmakers and leaving behind informative materials to bolster their opposition to FI consolidation. As legislators transitioned from the Legislative Office Building to the Capitol, they were met with chants of "No to One FI!" and a sea of signs championing the cause. The solidarity among diverse stakeholders, united in pursuit of a common goal, infused the atmosphere with optimism and determination.

Complementing in-person advocacy efforts, over 1,000 online activists mobilized that day, amplifying the message to lawmakers and Governor Hochul through digital channels. This coordinated approach left an indelible impression and underscored the breadth of support for the cause.

We wish to especially note the hard work of our planning group who worked throughout the weekend to make sure that Monday's Day of Action was impactful. From drafting press releases to organizing a scripted press conference, their meticulous preparation was instrumental in rallying support. HCP 2024 Legislative Retrospective

Summary of State Budget Proposals and Outcomes

MEDICAID PROPOSALS

- Cut \$200 million from Medicaid Long-Term Care plus an additional unallocated \$200 million.
 - HCP Position: Strongly opposed.
 - Outcome: The Senate and Assembly rejected and bought back the cuts by imposing a tax on MCOs.
- Repeal the 30-Day Look-Back Period for Medicaid Home Care Services:
 - HCP did not take a position.
 - Outcome: Rejected in the enacted budget.
- OMIG Audit of Home Care Providers' EVV Compliance:
 - HCP Position: Requested reforms to OMIG audit practices.
 - Outcome: No EVV penalty revenue for 2024; penalties for non-compliance will add \$20 million in 2025.







CONSUMER DIRECTED PERSONAL ASSISTANCE PROGRAM (CDPAP) PROPOSALS

- Repeal the Fiscal Intermediary RFP, replace it with an authorization process, and impose various restrictions.
 - HCP Position: Strongly opposed.
 - Outcome: Creation of a Statewide Fiscal Intermediary with limited subcontractors, rejecting most of the other proposals.
- Eliminate PAs from Worker Wage Parity
 - HCP Position: Opposed.
 - Outcome: Rejected, but may be impacted by broader changes to CDPAP.






HOSPITAL/HOME CARE/PHYSICIAN COLLABORATION PROGRAM PROPOSAL

- Allow hospitals to provide home care without a license.
 - HCP Position: Opposed.
 - Outcome: Rejected in the enacted budget.



MANAGED CARE PROPOSALS

- Impose a tax on Managed Care Organizations (MCO) to generate approximately
 \$4 billion over three years.
 - HCP did not take a position.
 - Outcome: Enacted budget creates the Healthcare Stability Fund to receive \$350 million from the MCO tax, pending federal approval.
- Moratorium on MLTC Applications
 - HCP Position: HCP did not take a position.
 - Outcome: Rejected in the enacted budget.



DOH MID-SESSION SHIFTS

In the wake of the budget's enactment, two noteworthy changes were announced by DOH:

- On May 3, 2024, Adam Herbst, Deputy Commissioner of the Department of Health's Office of Aging and Long-Term Care (OALTC), announced his resignation. During his tenure, Herbst was instrumental in establishing the OALTC and co-leading the Master Plan for Aging initiative. Carol Rodat, formerly Special Advisor to Herbst, took a leadership role in the newly established Center for Hospice and Palliative Care.
- On May 9, 2024, the Department of Health announced changes in the payment structure for administrative services provided by Fiscal Intermediaries (FIs) under the Consumer Directed Personal Assistance Program (CDPAP). Intended to start on July 1 but subsequently delayed until August 1, FIs will bill plans for the administrative portion of their reimbursement, and plans will bill DOH according to a set fee schedule. The wage component of an FI's reimbursement will continue as an hourly rate but will be renegotiated with the administrative component removed. Plans must pass through the entire DOH administrative payment to providers. This change also signifies that the Department is serious about reigning in administrative costs in CDPAP.





State Legislative Session: One Month

A late state budget often means a compressed legislative session. Lawmakers prefer to be back in their districts for the summer, especially in election years, and this year was no different. It was unlikely that the legislative session would be extended, leaving scant time to address the fallout of the state's budget enactment. Once lawmakers returned from a brief break, they hit the ground running moving legislation quickly. HCP sent letters to legislative leaders stressing our strong support for legislation critical to home care, including our suite of priority bills.

With less than a month and only 18 session days left on the legislative calendar HCP remained committed to addressing several key issues outside the state budget, to accomplish as much as possible within the limited timeframe. These objectives collectively aimed to strengthen the home care system, ensuring fair practices, financial stability, and high-quality care for all individuals who rely on these essential services.

Goal: Improve the reimbursement rate-setting process, making it more transparent, predictable, and sustainable.

• Fair Pay Accountability Act: S6963 (Rivera) / A7335 (Paulin)

Goal: Reform the audit practices of the Office of the Medicaid Inspector General (OMIG).

• OMIG Audit Reform: S5329A (Harckham) / A6813 (Paulin)

Goal: Affirm the right of home care agencies to choose their billing vendors.

• Billing Entity Choice Bill: S6123 (Rivera) / A5750 (Paulin)

Goal: Maintain established administrative oversight by preventing waivers for hospitals in collaborative programs to bypass standard procedures.

2023-2024 LEGISLATIVE SESSION BY THE NUMBERS

This is the end of a 2-year legislative session. Any bills not acted upon will need to be reintroduced in the next session. Many bills that have been passed in both houses will be delivered to the governor over the summer and fall.

Look for updated tool kits to empower you to be a strong voice for your business and our industry.

The past year has shown that the "three people in a room" model of state budget-making is back, and our advocacy will reflect a shift that focuses on legislative leadership.
